Improved evolution equations for QCD

In perturbative QCD the scaling violating Q^2 -dependence of structure and fragmentation functions formally arises as a result of summation over all orders in leading logarithmic approximation (LLA) [1]. In axial gauge the leading contribution is obtained by restricting the sum over the tree diagrams with dressed propagators and vertices [2], while interference between different diagrams can be neglected. A consequence of these approximations is that the evolution of partons can be interpreted probabilistically [3], in fact the formation of a jet of partons initialized by a single parton resembles a shower due to an electron or a photon penetrating matter [4]. Konishi, Ukawa and Veneziano [5] developed a simple set of rules - Jet Calculus - to derive expressions for inclusive multiparton distributions and parton multiplicities based on LLA. Recently Bassetto et al. [6] extended some of these considerations to study e.g. transverse momentum effects for multiplicity distributions as well as preconfinement [7].

The formulas derived on the basis of LLA are elegant and relatively simple. However, the simplicity is due to strong kinematic approximations and there are indications from, e.g. QED, that LLA can be quantitatively rather misleading. The main purpose of the present work is to derive rules and quantities which preserve exact kinematical relations in the parton branching process. In this way one can estimate the size of corrections to LLA. However, we have not really improved the QCD treatment beyond LLA. Our method is also suited to an efficient numerical calculation of any exclusive or inclusive quantity at the parton level using Monte Carlo simulation.

The kinematics relations are simplest when one uses as the scaled variable the light cone variable z denoting the energy + longitudinal momentum fraction

Summary

Evolution equations based on probabilistic interpretation of QCD are derived. The main improvement is the inclusion of exact off mass shell kinematics in parton branching, which permits a realistic Monte Carlo simulation of the jet evolution.

of a parton from the parent parton:

$$Z = (E_1 + p_{N1}) / (E + |p_1|) \quad (1)$$

In the branching vertex $p \rightarrow p_1 + p_2$ the following exact formula holds

$$p^2 = \frac{p_1^2}{2} + \frac{p_2^2}{1-z} + \frac{\vec{p}_T^2}{z(1-z)} \quad (2)$$

where \vec{p}_T is the transverse component of p_1 perpendicular to p . In LLA the dominant contribution comes from the region $p_1^2, p_2^2 \ll p^2$, thus p_1^2 and z -distributions become independent. In the phase space integral p_1^2 and p_2^2 are integrated up to p^2 , which results in a numerically significant contribution from a kinematically forbidden part of the phase space.

Let us next consider the discontinuity of a quark propagator or, in probabilistic interpretation the distribution of the valence quark of (off shell) mass Q_0 in the fragments of a quark created e.g. in e^+e^- annihilation at c.m. energy $Q \gg Q_0$. As in LLA [1-6] we shall consider tree diagrams only, further we shall replace the dressed vertices and propagators by the running coupling constants and bare propagators, while we keep the exact kinematics relations and the correct phase space integral. Remembering that the probability for finding a valence quark in a quark is unity, we obtain

$$1 = N_q(Q^2) \sum_{m=0}^{\infty} \int_m(\alpha_s^2, q_1^2, \dots, q_m^2, p_1^2) \quad (3)$$

where $\Gamma_0 = 1$ and (see Fig. 1)

$$\int_m(\alpha_s^2, q_1^2, \dots, q_m^2, p_1^2) = \int \prod_{k=1}^m \frac{\alpha_s(p_{k+1}) d p_{k+1}^2}{2\pi p_{k+1}^2} P(z_k) \theta(p_{k+1}^2 - \frac{p_k^2}{z_k} - \frac{q_k^2}{1-z_k}) dz_k \quad (4)$$

$$P(z) = \frac{4}{3} \frac{1+z^2}{1-z} \quad (5)$$

For clarity we have assumed that gluons do not decay and in order to get a finite result we take $q_k^2 = Q_0^2$. The factor $N_q(Q^2)$ is the unbalanced re-normalization constant which is left over, when dressed propagators and vertices are recombined into running coupling constants [2]. Alternatively we may consider eq. (3) as a definition of $N_q(Q^2)$ according to the Kinoshita-Lee-Nauenberg theorem. Physically interpreted $N_q(Q^2)$ is the probability that the quark is created (in the e^+e^- annihilation vertex or some other hard process) directly with mass Q_0 and hence does not emit gluons corresponding to the term Γ_0 in eq. (3).

To generalize eq. (3) to contain gluon decays we have to sum over all possible branchings of each of the gluons. If there were no kinematic correlations between gluons and the valence quark under consideration in eq. (3), each branch would just contribute a factor 1. In the absence of such correlations there exists thus a normalization condition for the gluon "form factor" $N_g(Q^2)$ similar to eq. (3). N_q and N_g are the QCD analogues of the Sudakov form factor. Due to the cutoff Q_0 they are both finite, but will rapidly tend to zero, when Q_0 decreases. In the case of QCD eq. (3) contains $\alpha_s(4Q_0^2)$, and the condition $\alpha_s(4Q_0^2)/\pi \ll 1$ must be satisfied, hence $Q_0 \gg \Lambda/Q$. The normalization condition (3) and the limitation to the class of tree diagrams

as the final result. The indicated sum applies only for gluons, in that case $\Gamma_g = \Gamma_{g \rightarrow gg} + \Gamma_{g \rightarrow q\bar{q}}$ corresponding to the two decay channels. We emphasize that the equation obtained does not involve any approximations after the form of the matrix elements in terms of the Altarelli-Parisi functions and renormalization conditions (8) have been fixed. For a classical relativistic branching process this would be an exact solution.

To assess the significance of eq. (9) it is important to see how it reduces to the known results in LLA. In view of the fact that we have not really rigorously solved QCD beyond LLA but only indicated a possible form of the generalization based on branching ideas, the fact that eqs. (8)-(9) reproduce the LLA results is nearly as good a derivation of eqs. (8)-(9) as the one given earlier. As pointed out above one assumes in LLA $p_a^2 \gg p_b^2, p_c^2$ in a vertex $a \rightarrow b, c$, which decouples p_b^2, p_c^2 and z distributions, nevertheless one integrates p_b^2 and p_c^2 up to p^2 . Performing these approximations in eq. (9) and using eq. (8) in the integration over p_b^2 and p_c^2 , eq. (9) reduces to the simple LLA form

$$\Gamma_a(p^2) \simeq \sum \frac{\alpha_s(p^2)}{2\pi p^2} \int P_{a \rightarrow bc}(z) \theta(p^2 - \frac{Q_0^2}{z} - \frac{Q_0^2}{1-z}) dz \quad (10)$$

As seen below this is numerically a very poor approximation, since it grossly overestimates Γ_a . Neglecting p^2 dependence of α_s and extracting the leading logarithms we obtain ($C_F = 4/3$)

$$\frac{N_q(Q^2)}{N_q(Q_0^2)} \simeq \exp \left\{ - \frac{\alpha_s}{2\pi} C_F \left(\log^2 \frac{Q^2}{Q_0^2} - \frac{3}{2} \log \frac{Q^2}{Q_0^2} \right) \right\} \quad (11)$$

specify the solution completely without further approximations. It is simplest to represent the solution in the form of an integral equation as follows: Firstly we shall redistribute the factors N_q and N_g in such a way that the propagator for a parton of type a becomes

$$\frac{N_a(p^2)}{N_a(p_a^2)} = \frac{\alpha_s(p_a^2) d p_a^2}{2\pi p_a^2} \quad (6)$$

where p^2 is the off shell mass squared of the parent parton. As in eq. (3) at each vertex $a \rightarrow bc$ there will be a factor

$$P_{a \rightarrow bc}(z_b) \theta(p_a^2 - \frac{p_b^2}{z_b} - \frac{p_c^2}{1-z_b}) dz_b \quad (7)$$

where $P_{a \rightarrow bc}$ are suitably normalized Altarelli-Parisi decay functions without δ -functions. Sum of the tree diagrams using rules (6-7) gives directly the cross section. Without loss of generality we can assume $N_q(Q_0^2) = N_g(Q_0^2) = 1$, the normalization condition (3) can then be written in the form

$$1 = N_a(Q^2) + \int \frac{N_a(Q^2)}{N_a(p^2)} \Gamma_a(p^2) d p^2 \quad (8)$$

where $\Gamma_a(p^2)$ represent the sum of all diagrams, where the parton a decays. Writing the decay explicitly using our rules (6-7) one gets

$$\Gamma_a(p^2) = \sum \frac{\alpha_s(p_a^2)}{2\pi p_a^2} \int P_{a \rightarrow bc}(z) \theta(p_a^2 - \frac{p_b^2}{z} - \frac{p_c^2}{1-z}) dz \times \frac{N_b(p_b^2)}{N_b(p_a^2)} \left[\delta(p_b^2 - Q_0^2) + \Gamma_b(p_b^2) \right] \frac{N_c(p_c^2)}{N_c(p_a^2)} \left[\delta(p_c^2 - Q_0^2) + \Gamma_c(p_c^2) \right] d p_b^2 d p_c^2 \quad (9)$$

If one could set $\alpha_S = \alpha_S(Q_0^2)$ this would agree with the Sudakov form factor derived in ref. [8]. In our case, however, the steps leading to eq. (11) cannot be numerically justified. Among others, notice that eq. (11) does not satisfy the factorization property discussed below.

In order to carry out a numerical solution of eqs. (8)-(9) we first note that eq. (8) simply tells that $\Gamma(Q^2)$ is the logarithmic derivative of $N(Q^2)$

$$\Gamma_a(Q^2) = -\frac{d}{dQ^2} \log N_a(Q^2); \quad N_a(Q^2) = \exp \left\{ - \int_{Q_0^2}^{Q^2} \Gamma_a(p^2) dp^2 \right\} \quad (12)$$

Substituting this into eq. (9) one obtains coupled nonlinear integral equations for $\Gamma_a(p^2)$, which are rather easy and fast to solve numerically. The simplicity is due to the fact that $\Gamma_a(p^2)$ is given in terms of $\Gamma_a(p^2)$, where $\sqrt{p^2} \leq \sqrt{p^2} - Q_0$, hence the solution can be integrated in a single iteration. Values of $N_q(Q^2)$ obtained from this procedure are plotted in Fig. 2. One can see that a change of Q_0 has a noticeable effect only at small virtual masses, which indicates the correct infrared behaviours. The shape of $N_g(Q^2)$ is very similar, except that the slope is approximately a factor 2 steeper than that of $N_q(Q^2)$. Fig. 2 also shows for comparison the LLA result based on eq. (11) [8]. The right hand side of eq. (11) describes a transition from the mass scale Q^2 to Q_0^2 , which should be given by the ratio of N-functions. For comparison (in accordance with eq. (22) of ref. [8]) we therefore plot the function

$$N'_q(Q^2) = \text{const} \cdot \exp \left\{ \frac{\alpha_S(Q^2)}{2\pi} C_F \left(\log^2 \frac{s}{Q^2} - \frac{3}{2} \log \frac{s}{Q^2} \right) \right\} \quad (13)$$

with $s = (100 \text{ GeV})^2$ as a function of Q^2 normalized to $N'_q = N_q$ at $Q^2 = s$. The validity of the derivation [8] of eq. (13) is $\sqrt{s} \ll Q^2 \ll s$. The present treatment clearly leads to numerically very important modifications compared to LLA.

As the kinematical constraints are correctly included it is straightforward to proceed to Monte Carlo simulation of parton branching. One simply has to generate three numbers z, p_a^2, p_b^2 at a given branching vertex according to the independent distributions $P(z), [\delta(p_a^2 - \alpha_0^2) + \Gamma_b(p_b^2)] / N_b(p_b^2)$ and $[\delta(p_c^2 - \alpha_0^2) + \Gamma_c(p_c^2)] / N_c(p_c^2)$, where $N(p^2)$ and $\Gamma(p^2)$ are the solutions of eqs. (8)-(9). If the values are outside the allowed kinematic domain, a new triplet z, p_a^2, p_c^2 has to be repeatedly generated until the Θ -function constraint is satisfied. For gluons one actually must keep separately

$\Gamma_{g \rightarrow gg}$ and $\Gamma_{g \rightarrow q\bar{q}}$ as well as $N_{g \rightarrow gg}, N_{g \rightarrow q\bar{q}}$ defined in an obvious way using eq. (12), since the generation of the gluon mass determines at the same time the future decay channel. The above Monte Carlo simulation nicely demonstrates the probabilistic interpretation of our formalism. Once a parton has been created with definite momentum (and for gluons with the information about the decay channel) its decay is independent of what happens to the other partons. In LLA the distributions of z, p_b^2 and p_c^2 in a vertex $a \rightarrow b, c$ would also be independent, which is impossible due to kinematics. In our case these distributions are otherwise independent except that they are coupled by the Θ -function. The normalization conditions (8), which are crucial for the correct cancellation of infrared real and virtual singularities, together with the integral equations (9) take care of the proper normalization of the joint probability density. A quantity like $N_q(Q^2)$ is interpreted as the probability for a quark created from a parton of mass Q to get the mass Q_0 without kinematics constraint. Notice that with probabilistic interpretation all parton form

factors describing a transition $(6) Q^2 \rightarrow P_a^2$ will be factorizable $N_a(Q^2)/N_a(p_a^2)$, since the probability $N(Q^2 \rightarrow Q_0^2) (\equiv N_a(Q^2)) = N(Q^2 \rightarrow p_a^2) \times N(p_a^2 \rightarrow Q_0^2)$. Correspondingly the total gluon form factor $N_g(Q^2)$ is the product $N_g = N_{g \rightarrow gg} \times N_{g \rightarrow qq}$, since the decay rates are additive $\Gamma_g = \Gamma_{g \rightarrow gg} + \Gamma_{g \rightarrow qq}$. In order to generate a gluon mass in practice one has to generate two masses using $N_{g \rightarrow gg}$ and $N_{g \rightarrow qq}$ independently and choose the larger mass. This is of course distributed according to $[\delta(p^2 - Q_0^2) + \Gamma_g(p^2)] / N_g(p^2)$. In Fig. 3 we have plotted the scaled momentum distribution of a valence quark in a quark. $D(p_{||}/Q)$ and $D(\perp|/Q)$ are our results for $Q = 30$ GeV, $Q_0 = 1$ GeV. $D_{q/q}^{LLA}(z)$ is the usual non-singlet fragmentation function, the moments of which are

$$D_{q/q}^{LLA}(n) = \left[\frac{\alpha_s(Q^2)}{\alpha_s(Q_0^2)} \right]^{d_n} \quad (14)$$

with $Q_0^2 = 6$ GeV². It is evident that the effect of exact kinematics is to slow down the evolution appreciably, hence the standard estimates based on LLA can at best be qualitatively correct. Notice, however, that in our case the evolution ends at $4Q_0^2$ (4 GeV² in Fig. 3), since $N_a(Q^2) = 1$ for $Q^2 \leq 4Q_0^2$. In Fig. 4 we have made a comparison with data on opposite side correlation from PETRA as measured by PLUTO [10] at 30 GeV. For this purpose we have included fragmentation into hadrons using a string picture [11]. Firstly we arrange all partons created in the evolution into preconfinement clusters [7]. After that each gluon is further split into $q\bar{q}$ using $P_{g \rightarrow q\bar{q}}$ distribution. The resulting strings are split into hadrons with a Feynman-field type algorithm [12] keeping the exact energy-momentum conservation for each string. Opposite side correlations should be sensitive to small deflection of quark and the antiquark due to nearly collinear gluon emissions. As pointed out by

the PLUTO collaboration [10] a standard Monte Carlo program without QCD evolution was in slight disagreement with data on angular correlations. With our present formalism the QCD evolution seems to be sufficient to produce the required effect in rough agreement with data. In conclusion, we have presented a simple way of estimating the subleading log corrections to QCD evolution equations and shown that these corrections are likely to be sizeable. The method of generalizing QCD evolution equations leads in a straightforward way to Monte Carlo simulation of parton branching. First applications indicate that agreement with data is improved; the method can be applied to several other processes.

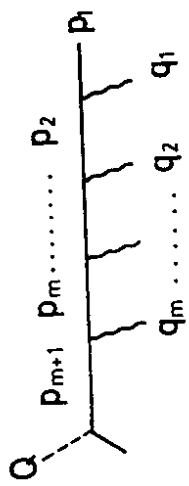

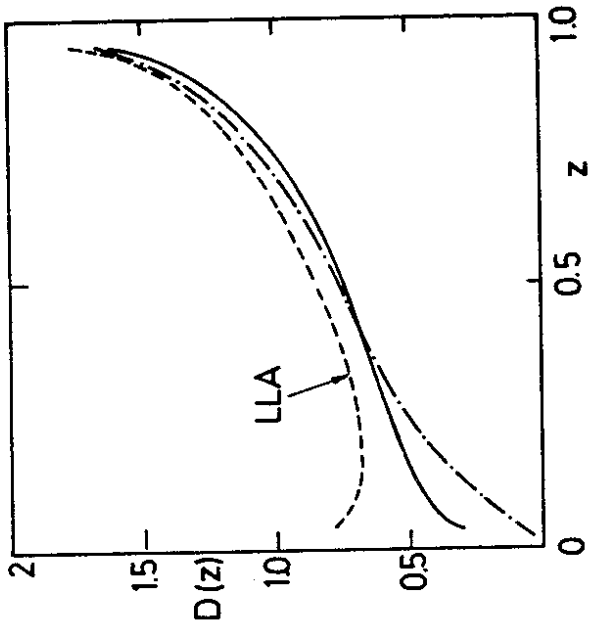

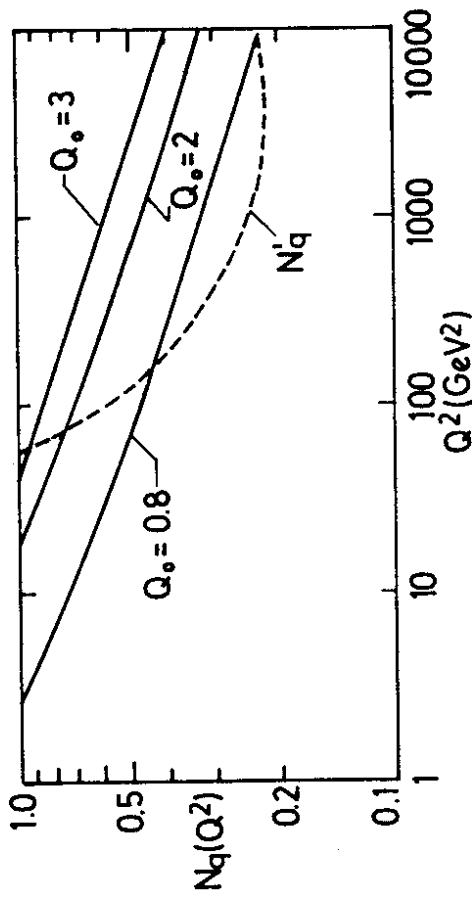

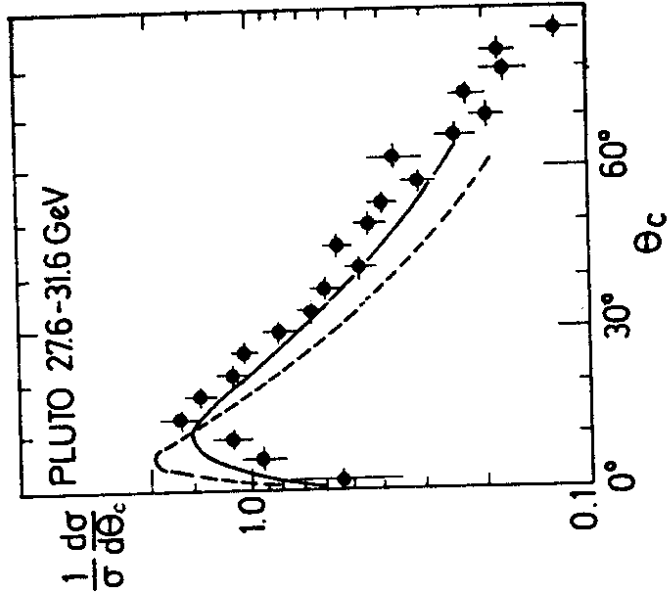
