Hadron Scattering in an Additive Eikonal Quark Model

Abstract

Total and differential cross sections for $\bar{p}p$, pp , π^+p , K^+p and ψp at high energies are analysed in an additive eikonal quark model. It is shown that the exceptionally small ψp slope contradicts the Chou-Yang model at present energies but can be accounted for by a quark-quark potential with different ranges for different pairs of quarks. This leads to smaller rms radii for hadrons than those derived from e.m. formfactors, implying that the constituent quarks have formfactors. Predictions for hadron-neutron and strange and charmed hadron-nucleon scattering are derived.

The purpose of this letter is to extend the additive quark model, which has been quite successful in relating total hadronic cross sections¹⁻³⁾, to describe the differential cross sections as well. Our model, besides being phenomenologically very useful, gives information on the structure of hadrons and on quark-quark interactions. While the systematics of total cross sections $\sigma_{pp}^- > \sigma_{pp}^+ > \sigma_{\pi p}^- > \sigma_{\pi p}^+ > \sigma_{K p}^- > \sigma_{K p}^+ > \sigma_{\psi p}^- > \sigma_{\psi p}^+$ could be simply attributed to different strengths of quark-quark scattering amplitudes, a more complicated mechanism is necessary to explain the identical inequalities among the forward slopes of differential cross sections, $B_{pp}^- > B_{pp}^+ > \dots$ etc.

Unlike the usual additive quark model we assume additivity at the level of eikonals⁴⁾ rather than amplitudes⁴⁾, i.e.

$$\chi_{ij}^{AB}(s,b) = \sum_{i,j=1}^{2N} n_i^A n_j^B \chi_{ij}^{AB}(s,b), \quad (1)$$

where n_i^A is the number of quarks (antiquarks) of type i in particle A and N is the number of flavours. This "additive eikonal quark model" could, for example, be justified using a potential model in eikonal approximation in which case χ_{ij}^{AB} is given by

$$\chi_{ij}^{AB}(s,\vec{b}) = \int_{-\infty}^{\infty} dz \int d^3r_1 d^3r_2 \rho_A(\vec{r}_1) \rho_B(\vec{r}_2) I_{ij}^{AB}(s,\vec{r}_1+\vec{r}_2). \quad (2)$$

*¹) is the density distribution of quarks in hadron h and I_{ij}^{AB} is the effective quark-quark potential, which may also depend on the interacting hadrons, as will be discussed later. If we classify the quark eikonals similarly to Lipkin²⁾

$$\begin{aligned} \chi_{\bar{d}\bar{d}} &= \chi_{u\bar{u}} = \chi_a, \\ \chi_{u\bar{u}} &= \chi_{\bar{d}\bar{d}} = \chi_{u\bar{d}} = \chi_{d\bar{u}} = \chi_d, \\ \chi_{s\bar{d}} &= \chi_{\bar{s}\bar{d}} = \chi_{s\bar{u}} = \chi_{\bar{s}\bar{u}} = \chi_s, \\ \chi_{c\bar{d}} &= \chi_{\bar{c}\bar{d}} = \chi_{c\bar{u}} = \chi_{\bar{c}\bar{u}} = \chi_c, \end{aligned} \quad (3)$$

and assume that $\chi_{a,d,s,c}$ are independent of AB, we get immediately Lipkin's sum rules but at the level of eikonals instead of total cross sections. Unfortunately, the eikonal is rather difficult to calculate directly from experiment⁵⁾; in particular, $d\sigma/dt$ must be known for large $|t|$ and with high accuracy. Therefore, instead of checking the eikonal relations directly, we prefer to parameterize the eikonals and compare the resulting differential and total cross sections with experiment.

Approximating the scattering amplitude, for simplicity, by a purely imaginary exponential, $f = i\sigma^{\text{tot}} \exp(bt/2)/(4\sqrt{t})$, gives

$$\frac{\partial \bar{\chi}(s,t)}{\partial t} / \bar{\chi}(s,t) \Big|_{t=0} = \frac{1}{2} B g(Y), \quad Y_{AB} = \sigma_{AB}^{\text{tot}}/4 B_{AB} \quad (4)$$

with $g(Y) = \left(\frac{\sigma}{n} \frac{Y^n/n^2}{\sum_{n=1}^{\infty} Y^n/n^2} \right) / \left(\frac{\sigma}{n} \frac{Y^n/n^3}{\sum_{n=1}^{\infty} Y^n/n^3} \right)$; here $\bar{\chi}(s,t)$ is the Fourier-Bessel transform of the eikonal. On the other hand, from eq. (2) we get

$$\bar{\chi}_{ij}^{AB}(s,t) = \bar{\rho}_A(t) \bar{\rho}_B(t) I_{ij}^{AB}(s,t), \quad (5)$$

so that (in case $\chi_{AB} \propto \chi_{ij}^{AB}$ with one type of χ_{ij})

$$B_{AB} = \frac{1}{3} g(Y_{AB}) (\langle r_A^2 \rangle + \langle r_B^2 \rangle + \langle r_{ij}^2 \rangle), \quad (6)$$

where "-" denotes the 3-dim. Fourier transform ($t = -\vec{k}^2$), $\langle r_A^2 \rangle$ is the mean square radius of particle A and $\langle r_{ij}^2 \rangle = \int r^2 I_{ij}(\vec{r}) d^3x / \int I_{ij}(\vec{r}) d^3x$ is a measure of quark-quark interaction range. In the high energy region, where $Y \approx \sigma^{\text{tot}}/4\pi B < 1$ for all hadronic reactions, $g(Y)$ is a monotonic function, satisfying $1 = g(0) \leq g(Y) \leq g(1) =$

= 1.368.

Applying (6) simultaneously to $\psi\psi$ and pp and using $g(Y_{\psi\psi}) = 1.0$, $g(Y_{pp}) = 1.18$ and $B_{pp} = 9.6 \text{ GeV}^{-2}$ (for $P_{\text{lab}} = 50 \text{ GeV}/c$), gives

$$\begin{aligned} \langle r_{\psi}^2 \rangle &= 3 [B_{\psi\psi}/g(F_{\psi\psi}) - \frac{1}{2} B_{pp}/g(F_{pp})] + \frac{1}{2} \langle R_d^2 \rangle - \langle R_c^2 \rangle \\ &= 3 (B_{\psi\psi} - 4.1 \text{ GeV}^{-2}) + \frac{1}{2} \langle R_d^2 \rangle - \langle R_c^2 \rangle, \end{aligned} \quad (7)$$

where we used $\langle R_{\bar{d}\bar{d}}^2 \rangle = \langle R_{d\bar{d}}^2 \rangle = \langle R_{\bar{c}\bar{c}}^2 \rangle$ and $\langle R_{\bar{c}\bar{d}}^2 \rangle = \langle R_{c\bar{d}}^2 \rangle = \langle R_c^2 \rangle$ (see (3)). Hence, the Chou-Yang model⁶⁾ with contact quark-quark interaction, $I_{qq}(\vec{r}) = \delta(\vec{r})$ or, equivalently, $\langle R_d^2 \rangle = \langle R_c^2 \rangle = 0$, would lead to negative $\langle r_{\psi}^2 \rangle$ as long as $B_{\psi\psi} < 4.1 \text{ GeV}^{-2}$. Even the largest slope of $B_{\psi\psi} = 2.9 \pm 0.3$, deduced from photoproduction experiments up to $E_{\gamma} = 100 \text{ GeV}$, leads to a contradiction.

One possible way out is to assume that different pairs of quarks have different interaction ranges, in particular $\langle R_d^2 \rangle \gg 2 \langle R_c^2 \rangle$. However, since $\langle r_{pp}^2 \rangle = \langle r_{\psi\psi}^2 \rangle + \frac{3}{2} B_{pp}/g(Y_{pp}) - \frac{1}{2} \langle R_d^2 \rangle = (0.7)^2 \text{ fm}^2 - \frac{1}{2} \langle R_d^2 \rangle$, a large $\langle R_d^2 \rangle$ would lead to a smaller rms radius for proton than the one following from its e.m. formfactor, $6dF(t)/dt|_{t=0} = (0.8)^2 \text{ fm}^2$. To account for the difference one has to assume that constituent quarks themselves have their own formfactors. Then the observed e.m. formfactor of hadron F_h would be given roughly by the product $Q_h F_h(t) = \bar{\rho}(t) \rho_q(t)$, where Q_h are the charges of the constituent quarks and $F_q(t)$ are their e.m. formfactors. This point will be discussed in more detail elsewhere⁷⁾.

To test this idea we use the following simple parametrization of the density distribution and quark-quark effective potential

$$\rho_A(r) = \pi^{-3/2} r_A^{-3} \exp(-r^2/r_A^2), \quad (8)$$

$$I_{ij}^{AB}(s,r) = \gamma_{ij}^{AB}(s) \lambda_{ij}(s) \exp(-r^2/R_{ij}^2(s)) + \gamma_{\text{core}}^{AB}(s) \lambda_{ij}^{\text{core}}(s) \exp(-r^2/R_{\text{core},ij}^2(s)). \quad (9)$$

The corresponding eikonals are

$$\chi_{ij}^{AB}(s,b) = \epsilon_{ij}^{AB}(s) \exp(-b^2/R_{ij}^2) + \epsilon_{\text{core},ij}^{AB}(s) \exp(-b^2/R_{\text{core},ij}^2), \quad (10)$$

where

$$\epsilon_{ij}^{AB} = \gamma_{ij}^{AB} \lambda_{ij} \frac{\sqrt{\pi} R_{ij}^3}{r_A^2 + R_{ij}^2}, \quad (11)$$

$$\bar{R}_{ij}^2 = r_A^2 + r_B^2 + R_{ij}^2,$$

and similarly for the core.

To explain the meaning and the role of different parameters in the above ansatz, we shall start by assuming drastic simplifying relations among them and then relax some of these gradually, showing the improvement of the fit as the number of parameters grows. We base our fit on 6 reactions, pp, $\bar{p}p$, $\pi^+\bar{p}$ and $K^+\bar{p}$, and for every one of them we use 6 data points: σ^{tot} , B (with additional weight 9 to give B equal footing with σ^{tot} in the fit) and 4 points of $d\sigma/dt$.

In Fig. 1 we illustrate the improvement of our fit by plotting σ^{tot} and B together with χ^2 for all fitting steps and in Fig. 2 the differential cross sections resulting from the final fit. Now, we shall shortly review the successive approximations*).

Step 1 (2 parameters): $\lambda_{ij} = \lambda$, $R_{ij} = R$, $\lambda_{ij}^{\text{core}} = 0$ for all i, j ;

$$Y_{AB} = 1, r_A = r_B = r_h = 0.28 \text{ fm} \quad \text{for all } A, B.$$

The above common value r_h for all hadrons, corresponding to a rms radius $\sqrt{\langle r_h^2 \rangle} = \sqrt{1.5} r_h^2 = 0.34 \text{ fm}$, is chosen as large as possible within the limits imposed by $B_{\psi\psi}$ **). These assumptions leave us with 2 parameters only, R and λ , but already at this stage the quark counting rule at the eikonal level, $\chi_{bb} = \frac{9}{6} \chi_{mb}$, gives a splitting of both σ^{tot} and B^{tot} into common values for mesons and baryons.

Step 2 (4 parameters). Allow for different ranges of quark interactions according to classification (3): $R_a > R_d > R_s$. In particular, the inequality $R_a > R_d$ leads to $\bar{p}p > \bar{p}p$, $\pi^+\bar{p} > \pi^+\bar{p}$, $K^+\bar{p} > K^+\bar{p}$ for both σ^{tot} and B. Note that although λ is still common for all quarks, the corresponding g 's will split, $g_a > g_d > g_s$.

Step 3 (5 parameters). The observation that σ_b^{tot} is always smaller whereas σ_m^{tot} always larger than experiment (see Fig. 1) lead us to introduce a phenomenological parameter $\gamma_b > \gamma_m = 1$. This parameter is responsible for the difference between effective quark-quark couplings in meson-baryon and baryon-baryon scattering and could be attributed to the dependence of quark interactions on velocity.

city and different velocity distributions of quarks within mesons and baryons. If this is the case, then γ should approach unity as $s \rightarrow \infty$. The additional parameter γ_b improves the fit enormously (compare χ^2 in Fig. 1).

Step 4 (7 parameters). Although the above 5 parameter fit leads to very good results for σ^{tot} and B, the theoretical differential cross sections show a prominent dip at too low values of t ($\approx -1 \text{ GeV}^2$) for all 6 reactions. By introducing a core term, with $R_{\text{core},ij} < R_{ij}$, we can push the dip to larger values of t . For simplicity we add only 2 new core parameters: common coupling λ^{core} and a common ratio $\alpha = R_{\text{core},a}^2 / R_{\text{core},d}^2 = R_{\text{core},s}^2 / R_{\text{core},s}^2$ and assume $\gamma_b^{\text{core}} = \gamma_b$, $\gamma_m^{\text{core}} = 1$. Step 5 (7 parameters, $r_m \neq r_b$). The calculated baryon (meson) slopes are always smaller (larger) than the experimental values. This implies in our model that baryons have larger radii than mesons. Unfortunately, due to the limited range in t of present pp and $\bar{p}p$ data, from which no conclusion about the existence or position of the dip may be drawn, our fit is not very sensitive to the change of r_m and r_b . Therefore, we repeated step 4 with somewhat arbitrarily fixed values $r_m = 0.24 \text{ fm}$ and $r_b = 0.32 \text{ fm}$. This gives an excellent agreement with all present data (see Figs. 1, 2 and table 1). As we checked, the dip in pp can be pushed to larger momentum transfers by changing parameters r_m , r_b and α without substantial worsening of other reactions. The values of parameters obtained are: $R_a = 0.81 \text{ fm}$, $R_d = 0.73 \text{ fm}$, $R_s = 0.62 \text{ fm}$, $\lambda = 0.0156 \text{ GeV}$, $\gamma_b = 1.318$, $\alpha = 0.119$, $\lambda^{\text{core}} = 0.121 \text{ GeV}$. Note that λ couplings are real which corresponds to purely absorptive quark-quark potential.

For $\psi\bar{\psi}$ the experimental data have large uncertainties⁸⁻¹⁰: $1.25 \pm 0.2 < B_{\psi\bar{\psi}} < 2.9 \pm 0.3 \text{ GeV}^{-2}$ and $1 < \sigma_{\psi\bar{\psi}}^{\text{tot}} < 3 \text{ mb}$. To estimate the one additional charmed quark parameter, R_c , we used $B_{\psi\bar{\psi}} = 2.9 \text{ GeV}^{-2}$. Then $\sigma_{\psi\bar{\psi}}^{\text{tot}}$ is predicted to be 1.69 mb and $R_c = 0.30 \text{ fm}$.

Finally, we list in table 1 predictions for the total cross sections and slopes for several reactions and compare them with experiment when possible. Note the remarkable agreement with the experimental neutron data: less than 2% deviation from Fermilab data¹²⁾ and even better agreement with Serpukhov data¹³⁾. Unfortunately, the hyperon-nucleon scattering is measured only up to $p_{\text{lab}} = 21 \text{ GeV}/c$ so that direct comparison is not possible. However, the rough agreement is visible if one remembers that $\bar{\Lambda}p$ and $\bar{\Lambda}n$ decrease faster with energy than Λp and Λn , due to the strongly varying annihilation channel $\bar{d}d$ and $\bar{u}u$. The predictions for charmed particles are intended only as rough estimates.

We conclude that the additive eikonal quark model describes successfully the

different hadron scattering data. Our good fit shows implicitly that the quark model relations (3) are well satisfied within mesons and baryons respectively and indicates the necessity of breaking of simple additivity by introducing some additional difference between mesons and baryons (γ_b parameter). The interpretation given to the various parameters has important implications for the quark dynamics and the structure of hadrons. To gain a deeper understanding of this model we used it also to study the energy dependence of hadronic interactions. The results will be discussed elsewhere ¹⁸.

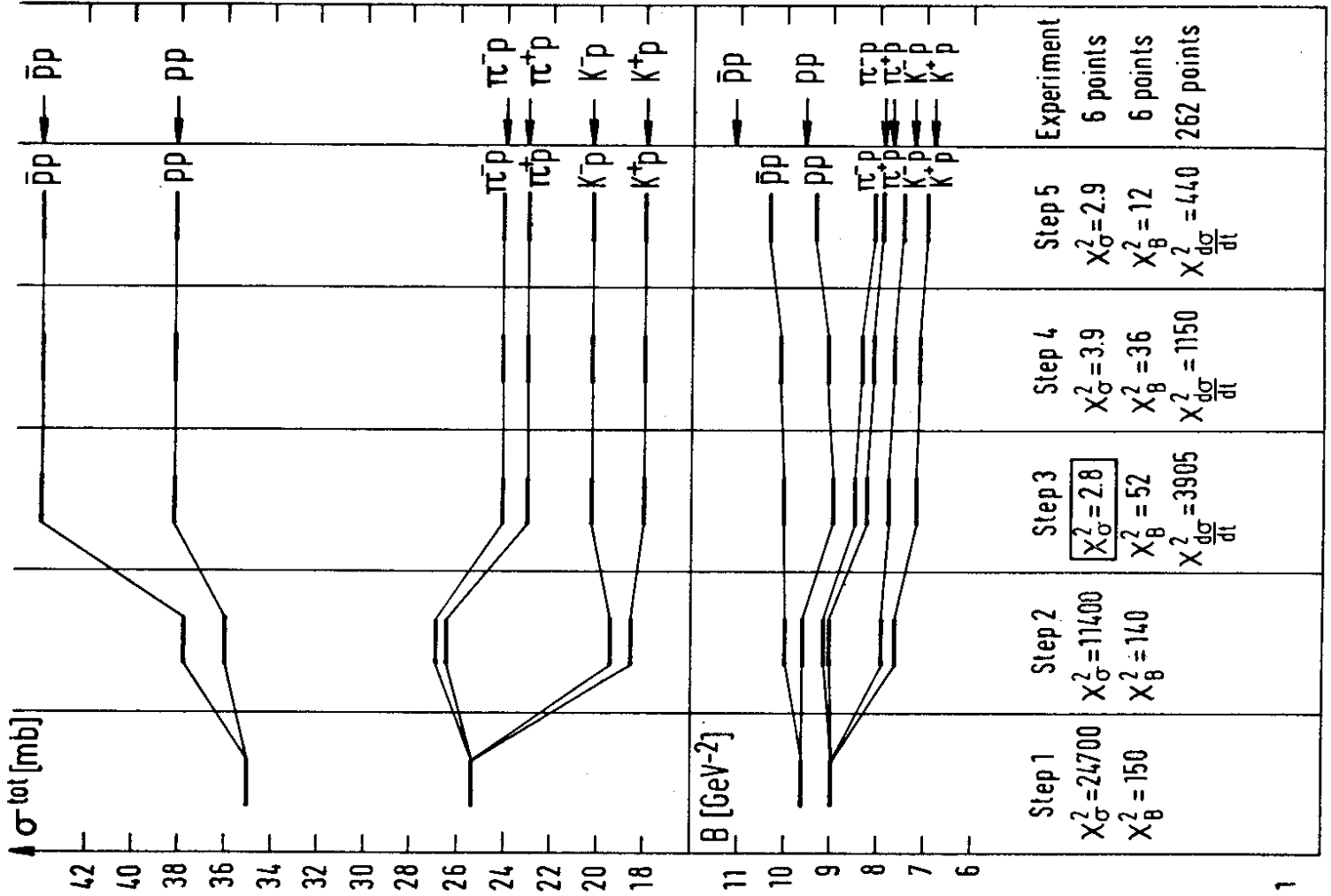
