WHEREAS, Manitoba First Nations have a Human Right, Inherent, Treaty and Aboriginal Rights; and

Seconded by:

Chief Murray Clearsky
Waywayseecappo First
Nation

WHEREAS, First Nations people have a Human Right, Treaty Right and an Inherent Right to Education; and

WHEREAS, First Nations people have the right to quality education comparable and equitable to other Canadians; and

CARRIED

WHEREAS, jurisdiction and authority for First Nation education resides with individual First Nation governments at the community level; and

WHEREAS, the federal government has a fiduciary responsibility to provide adequate resourcing for the education of First Nations people arising from treaties, historical relationships and the Canadian constitution.

THEREFORE BE IT RESOLVED, that the Assembly of Manitoba Chiefs take all necessary steps to ensure that:

1. The Federal Government fulfills its fiduciary responsibility to provide adequate resourcing for all aspects of First Nation education, while recognizing and respecting that the full jurisdiction of education lies with individual First Nation governments.
2. Any reform of First Nation education must guarantee that full jurisdiction for First Nation education remains with the individual First Nation governments, and that local and community control over education is never relinquished nor compromised.
3. Respect for the spirit and intent of Treaties, Treaty Rights and Inherent Rights of First Nation people must be a foundation for any federal policies regarding First Nation education.
4. Any Provincial government involvement with First Nation education must be based on a clear recognition of First Nations jurisdiction of education and an acknowledgement of the Federal government's fiduciary responsibility for First Nation education.

TERMS OF REFERENCE/PROTOCOL
TREATY RELATIONS COMMISSION OF MANITOBA (TRCM)**

Mandate:

The Assembly of Manitoba Chiefs (AMC) has mandated the establishment of a Council of Elders. A Terms of Reference and Protocol have been developed based on the Memorandum of Agreement (MOA) signed November 19, 2003 that includes Treaties 1, 2, 3, 4, 5, 6, 10, and the Dakota Nations (Manitoba).

Purpose:

The purpose of the Council of Elders is to provide advice and guidance to the AMC leadership and Treaty Commissioner in the objectives of the TRCM to honor and respect the sacred Treaties, to identify mutual obligations and benefits of Treaties 1, 2, 3, 4, 5, 6, 10 and the Dakota Nations to understand the spirit and intent of the Treaties and historical relationships.

Roles and Responsibilities:

The Terms of Reference and Protocol of sharing and teachings will guide the Council of Elders in carrying out their roles and responsibilities. The Council will:

1. Serve an advisory role to the TRCM to assist the parties in the MOA objectives in research, public education and discussion tables;
2. Provide advice and guidance to the AMC leadership and Treaty Commissioner on the spirit and intent, understanding and interpretation of the Treaties and international relations of First Nations;
3. Share their knowledge on First Nations oral histories, traditional and spiritual knowledge, cultural teachings, values, laws, ceremonies and protocols of the First Nations at treaty making;
4. Identify the appropriate First Nations protocols to be respected and adhered to by AMC and TRCM;
5. Be informed on the MOA, role of TRCM and Treaty Commissioner Accountability Profile/Terms of Reference and the TRCM Speakers Bureau;
6. Promote the protection and preservation of Creator-given lands, sacred sites, environment, nationhood, sovereignty, spirituality and the use of First Nation languages as key to understanding Treaties, traditions and cultures;
7. Respect other Elders' experiences and expectations based on equality and diversity of each Nation;

8. Provide advice and guidance on AMC's coordination/facilitation role in work plan activities and the development of Treaty-based strategies;
9. Serve as spiritual advisors by conducting or participating in ceremonies for AMC and TRCM; and
10. Abide by the Traditional Code of Ethics (adapted) (Appendix "A").

Accountability:

The Council of Elders will:

1. Maintain a reporting relationship to the Grand Chief, AMC Executive Council of Chiefs and Chiefs in Assembly;
2. Communicate their knowledge, history and teachings of First Nations on Treaties; and
3. Provide updates and involve other Elders at community meetings when required.

Qualities/Knowledge:

Representatives of the Council of Elders will have the following qualities/knowledge:

1. Be an original citizen of the Treaty/area they represent, including the Dakota;
2. Fluency in a First Nation language;
3. A knowledge carrier of First Nations oral history, traditions, teachings, cultures and ceremonies;
4. In-depth knowledge of First Nation world views, protocols, values, lands, livelihood and resources;
5. Respect, honor and recognize the Treaty obligations and benefits as 'living trees' capable of growth and development;
6. Have community-based experiences and Treaty knowledge and inherent rights;
7. Ability to communicate the principles of sharing and the spirit and intent of Treaties by Treaty area for each of the Nations;
8. Ability to make timely and knowledge-based recommendation and decisions; and
9. Understand and carry out the roles and responsibilities in accordance with the Council of Elders Terms of Reference and Protocol.

Representatives:

The Representatives of the Council of Elders are recognized as:

1. Historians and record keepers of First Nations oral teachings and Treaties;
2. Keepers of traditional knowledge in language and spiritual ceremonies;
3. Carriers, teachers and educators of oral histories, languages and traditions;
4. Ceremonial Treaty carriers and keepers;
5. Having a strong commitment to revitalize the sharing principles, spirit and intent of Treaties and Treaty-making;
6. Having an understanding of the importance of the spoken First Nations language for nationhood and identity;
7. Having the ability to translate and interpret their understanding of Treaties and historical relationships; and
8. Having a commitment to ensuring the sanctity of living Treaties to be continued in documented form based on First Nation language, teachings, culture and customs.

Term of Office:

Each of the representatives on the Council of Elders shall have a four-year term and be eligible for reappointment.

Vacancy:

When there is a vacancy on the Council of Elders, the Council may recommend names of Treaty knowledge carriers to the AMC Grand Chief for consideration for appointment.

Chairperson:

The Council of Elders shall appoint an official Chairperson and co-Chairperson who shall serve as the official spokesperson for the Council of Elders.

When a Treaty gathering is held in a specific Treaty area, then the Representative for that area shall be the official spokesperson.

All representatives of the Council of Elders shall also have the opportunity to Chair the Council of Elder meetings on a rotational basis.

Quorum:

A quorum for Council of Elders' meeting shall be 50% plus one (5 out of 9 representatives). If a quorum is not achievable, then the Representatives in attendance may meet as a sub-committee to review updates/reports and refer any recommendations to the next duly convened Council of Elders meeting.

Absence:

If a Representative on the Council of Elders misses three consecutive meetings without just cause, then the Council of Elders may recommend replacement of the Representative to the AMC Grand Chief.

Meetings:

Meetings will be held a minimum of four times a year. Meetings will be arranged by the AMC Treaty Relations Coordinator in consultation with the Chairperson and co-Chairperson of the Council of Elders or based on direction from the previous meeting of the Council of Elders.

Consensus:

Recommendations and advice will be determined by a consensus of the Council of Elders after consideration of various options.

TRADITIONAL CODE OF ETHICS (adapted):

1. Each morning upon rising, and each evening before sleeping, give thanks for the life within you and for all life, good things the Creator has given you, and for others for the fortuity to grow a little more each day. Consider your thoughts and actions of the past day, and seek for the courage and strength to be a better person. Seek for the things that will benefit everyone.
2. Respect means, "To feel or to show honor or esteem for someone or something; consider the well being of, or to treat someone or something with deference or courtesy". Showing respect is a basic law of life.
 - Treat every person, from the smallest child to the oldest Elder with respect at all times.
 - Special respect should be given to Elders, Parents, Teachers, and Community Leaders – Avoid profanity in the presence of Elders and others.
 - No person should be made to feel "put down" by you; avoid hurting other hearts as you would avoid a deadly poison.
 - Touch nothing that belongs to someone else (especially Sacred Objects) without permission, or an understanding between you.
 - Respect the privacy of every person. Never intrude on a person's quiet moment or personal space.
 - Never walk between or interrupt people that are conversing.
 - Speak in a soft voice, especially when you are in the presence of Elders, strangers, or others to whom a special respect is due.
 - Do not speak unless invited to do so at gatherings where Elders are present but do not hesitate to ask what is expected of you should you be in doubt.
 - Never criticize others or speak about others in a negative way, whether they are present or not.
 - Treat the earth and all of her aspects as your mother, show deep respect for the mineral, plant, and animal worlds. Do nothing to pollute the air or the soil.
 - If others would destroy our Mother, rise up with wisdom to defend her.
 - Show deep respect for the beliefs and religions of others.
 - Listen with courtesy to what others say, even if you feel that what they are saying is worthless to you. Listen to your heart.
3. Respect the wisdom of people in your Council. Once you give an idea to the committee or meeting, it no longer belongs to you. It belongs to the people.

Respect demands that you listen intently to the ideas of others if they are true and good, even if those ideas are quite different from the ones you have contributed. The clash of ideas brings forth the Spark of Truth.

4. Be truthful at all times, and under all conditions.
5. Always treat your guests with honor and consideration. Give your best food, best blankets, best part of your house, and best service to your guests.
6. The hurt of one is the hurt of all; the honor of one is the honor of all.
7. Receive strangers and outsiders with a loving heart and as members of the human family.
8. All the races and nations in the world are like the different colored flowers of one meadow. All are beautiful. As children of the Creator they must be respected.
9. To serve others, to be of some use to family, community, nation, or world is one of the main purposes for which human beings have been created. Do not fill yourself with your own affairs and do not forget your most important task. True happiness comes only to those who dedicate their lives to the service of others.
10. Observe moderation and balance in all things.
11. Know those things that lead to our well-being, and those things that lead to our destruction.
12. Listen to, and follow the guidance given to your heart. Expect guidance to come in many forms; in prayer, in dreams, in times of quiet solitude, and the words and deeds of wise Elders and friends.
13. Continue to use [the gift of laughter and] humor in dealing with Elders and others.

WHEREAS, at a Special Chiefs Assembly on Health & Housing on January 25 – 28, 2005, Resolution Jan-05.01 Manitoba First Nations Health & Wellness Strategy, Ten Years and Beyond 2005 was supported and endorsed by the Chiefs in Assembly; and

WHEREAS, the Manitoba First Nations Health & Wellness Strategy, Key Action A: Move Towards a More Effective Health Care System – Key Action Area One Health Care System Framework identified research and networking regarding the establishment of a Manitoba First Nations Health and Social Commission to design and implement better coordination of health and social services; and

WHEREAS, Manitoba First Nation citizens and communities have not received the same level of access to health care services, nor comprehensive program resources enjoyed by other Canadians; and

WHEREAS, the delivery of health services and programs to First Nations is fragmented, being left to jurisdictional debate by other governments, resulting in poorer health status of First Nations; and

WHEREAS, the Creating a Manitoba First Nations Health and Social Commission -Health Reform Project proposal was submitted to First Nations and Inuit Health Branch, Ottawa for funding consideration under the Aboriginal Health Transition Fund, Pan-Canadian Envelop and denied funding as a regional First Nation initiative; and

WHEREAS, the Creating a Manitoba First Nations Health and Social Commission - Health Reform Project will develop operational, programming, financing and accountability options and build consensus in three years for the Chiefs in Assembly to move forward in creating a Manitoba First Nation Health and Social Commission; and

1. Ensuring portability of health benefits under treaty and inherent rights for on/off reserve citizens.
2. Improving coordination between Federal and Provincial health programs and services.
3. Increasing First Nation participation in planning and management of health services with governments and their departments.
4. Promoting First Nation autonomy and control over our lives through exercising First Nation self determination and self government initiatives to restore greater authority over health

THEREFORE BE IT RESOLVED, that the Chiefs in Assembly support and endorse the “Health Reform Project: Creating a Manitoba First Nation Health and Social Commission”.

FURTHER BE IT RESOLVED, that the Manitoba First Nations Health and Social Commission - Health Reform proposal be re-submitted along with the Chiefs in Assembly resolution directly to the Federal and Provincial Ministers of Health for funding.

WHEREAS, the Political Action Plan on First Nations Health- Draft 5 identified 5 Key Plan Action Areas including First Nations Treaty Right to Health Implementation Strategy and the Chiefs-in-Assembly directed the AMC Research and Policy Development – Treaties and Treaty Commissioners office to undertake a historical research project on the Treaty Right to Health; and

CARRIED

WHEREAS, Treaty and Aboriginal Rights are recognized and affirmed under Section 35 in Canada's Constitution Act, 1982; and

WHEREAS, Article 5.3 of the Treaty Relations Commission Memorandum of Agreement (MOA) signed between Canada and the Assembly of Manitoba Chiefs, dated 19 November 2003 mandates that:

Without restricting the mandate of the Treaty Relations Commission or the Commissioner, understanding of Treaty issues that may be explored by the Parties, through oral history, traditional knowledge and archival information, include but not limited to, the following Treaty related issues:

- 5.3.1 *Social issues including: child & family, education, housing & health (emphasis added)*
- 5.3.2 *The inclusion of any subject matter is without prejudice to the respective position of the Parties on the content, scope or existence of any Treaty right or any assertion by a First Nation that they are covered by any existing Treaty.*

WHEREAS, Independent Sovereign First Nations entered into pre-confederation treaties amongst ourselves and with other foreign nations and Treaties with the British Crown and that the representatives of the Treaty signatories are the First Nation Chief and Council; and

WHEREAS, the AMC Constitution's mandate is to "promote, preserve and protect Aboriginal and Treaty Rights for First Nations people in Manitoba" in accordance with the principle that "Treaty Rights must be upheld and maintained"; and

WHEREAS, the AMC Chiefs-In-Assembly by resolution **Mar-01.30** mandated the establishment of a Treaty Relations Commission in Manitoba (TRCM); and

WHEREAS, the AMC and Canada (Her Majesty In Right of Canada as represented by Indian Affairs and Northern Development) signed the Memorandum of Agreement (MOA) on November 19, 2003; and

WHEREAS, The MOA mandated the AMC and Canada to establish a Treaty Relations Commission to respect and honour the bilateral Treaty relationship between the First Nations and the Crown; and

WHEREAS, The MOA recognizes the Treaty Relations Commission may invite the Province of Manitoba when appropriate and as agreed upon by the Parties; and

THEREFORE BE IT RESOLVED, that the Chiefs-in-Assembly support the continued development and implementation of a First Nations Education Database which incorporates the OCAP principles (ownership, control, access and possession) to be hosted by the Manitoba First Nations Education Resource Centre.



WHEREAS, the Standing Committee on Aboriginal Affairs published a report on Post-Secondary Education entitled *No Higher Priority – Aboriginal Post-Secondary Education in Canada* in February 2007 which called for adequate resourcing for post-secondary education student support by stating, “that the Department make it a priority to provide adequate funding under the PSE Program to every eligible First Nations and Inuit learner and put in place a plan to achieve that priority by the end of 2007, said plan to include implementation measures with clear target dates” and further “ that the Department ensure financial assistance for eligible First Nations and Inuit learners under the Department’s PSE program is based on actual costs incurred for tuition, travel and living expenses and indexed annually to reflect rises in both tuition costs and the cost of living.”; and

WHEREAS, former Indian Affairs Minister Jim Prentice’s response to the Standing Committee’s report was that, “The Government believes that a concept of shared responsibility must apply in providing support for Aboriginal post secondary education and that this entails exploring the range of resources available from public, institutional, non profit and private sector sources. Thus a learner might seek funding not only from Indian and Northern Affairs Canada's post secondary education programs but also from the Canada Student Loans Program (CSLP), the National Aboriginal Achievement Foundation, the Millennium Scholarships and private scholarships, as well as from personal and family sources.”; and

WHEREAS, a study by the Millennium Scholarship Foundation in June 2008 entitled *Factors Affecting The Use of Student Financial Assistance by First Nations Youth* has noted that "many First Nations youth are reluctant to explore other forms of PSE (e.g., provincial or Canada Student Loans, private lines of credit) because they prefer band funding (which is almost entirely grant-based), as opposed to other funding mechanisms that typically involve a repayable component. Often this is related to the recognition among First Nations youth that funding for education is a treaty obligation of the federal government."; and

WHEREAS, the Federal Government has a fiduciary responsibility to provide adequate resourcing for the education of First Nations people arising from treaties, historical relationships and the Canadian constitution.

THEREFORE BE IT RESOLVED, that the Assembly of Manitoba Chiefs Grand Chief convene a meeting with the Minister of Indian and Northern Affairs Canada and the Premier of Manitoba and the Cabinet members of the Province of Manitoba outlining the position of the Chiefs in Manitoba that post-secondary education is a treaty right as affirmed in the Canadian constitution and to call for First Nations to retain the PSSSP with additional and adequate resourcing for all eligible First Nations post-secondary students.






WHEREAS, the position of First Nations Chiefs in Manitoba is that AMC's priorities and strategies must include a resource-based agenda.


