# The EU-LAC Foundation commemorates its 10th Anniversary

We were not prepared for the painful and irreparable loss of millions of human lives and the global magnitude of the negative impact of the pandemic, which today makes us aware of the unsustainable action of our development model and how it limited our resilience capacities. The pandemic also made visible how global interdependencies generate problems that condition human security and how local health or environmental crises can turn into global crises, causing recessions that widen inequality gaps. Current economic and social challenges are urgent priorities for recovery, but the opportunity for real transformation will come from addressing pre-existing structural weaknesses and preparing for future global challenges. It can only be a sustainable recovery if it can also be inclusive and reach all people and countries in the world, including lower- and middle-income countries.

In a geopolitical context of growing global polarity, the relationship between Europe and Latin America and the Caribbean cannot be explained without incorporating the lessons learned during the pandemic. Dialogue and cooperation are the essential and indispensable lessons to be learned in order to face together the global challenges, many of which were already identified before this crisis and which have become more acute during it. Joining forces and overcoming the stagnation of the past, especially the common commitment to the 2030 Agenda and multilateralism, represents a valuable potential that gives us greater possibilities to accelerate the transformations we need.

In the time before the pandemic, despite the fact that global governance structures were questioned and lacked confidence, the European Union, Latin America and the Caribbean decided to give a boost to the EU-LAC Foundation as an international organisation for dialogue with the capacity to contribute to strengthening the bi-regional agenda. On the Foundation's tenth anniversary, I would like to highlight this added value as a meeting space that uniquely brings together 60 countries from the two regions, where governments can also connect with different actors from civil society and academia. A decade after our constitution, we remember Ambassador Jorge Valdez, who passed away recently. A distinguished Peruvian diplomat who was the first Executive Director of the Foundation and who, together with the organisation's first employee, Bettina Trüb, laid the foundations for its structure and strategic initiatives, on which we base our action. A legacy that encourages us to continue working with renewed enthusiasm to promote the visibility and dynamism of the Foundation's programme of work in the extraordinary and uncertain times we live in.

On this 10th anniversary, we have to thank the city of Hamburg for its hospitality as the Foundation's headquarters. A port city that is well acquainted with the challenges of navigation and the captaincy of a ship, a task that I took on at the Foundation together with Director Adrián Bonilla. In the midst of the storm, we got to know the crew, the committed team of the Foundation, which in a difficult year, has demonstrated its capacity for work and commitment. The pandemic has



not prevented us from designing a roadmap and reaching important agreements attained during the last meeting of the Board of Governors held recently. These include the approval of its new internal regulations - now homologated with its new nature as an international organisation - and the approval of eight new cooperation agreements with different partners of the Foundation for the joint implementation of activities and initiatives that will favour and enhance the implementation of our work programme. Even more important was the approval of the EU-LAC Foundation's Annual Work Programme for the year 2022, which incorporates the current context situation with the strengthened 2030 Agenda as the international consensus guide available.

From its holistic and multidimensional vision that connects the challenges of sustainable development, the Foundation will continue to deepen the lines of work aimed at promoting higher education, mitigating climate change, and promoting digitalisation. The effects of climate change will be far more profound and devastating than the pandemic and it is essential to promote a green economy that halves the level of global greenhouse gas emissions. Digitalisation and innovation, both in the productive and educational spheres and in public services, are another priority, especially the importance of digital technologies in maintaining social services, teleworking, transactions, education, or health care, which imposes the need for universal access to broadband services.

We have also refocused priorities on health or reducing inequalities. Achieving universal access to vaccines and minimising the impacts of new variants will be decisive and more effective through a multilateral response that strengthens cooperation between our regions. We aspire in these exceptional times to foster a useful dialogue that facilitates the sharing of the best knowledge and advances in scientific research between our regions, to generate impact on public health policies and to reinforce preparedness and response capacities for future crises.

The violated rights and widened inequality gaps for women, with increased workloads and lack of protection against gender-based violence, will be a new line of action for the Foundation. To this end, we have initiated the work of the

EU-LAC International Women's Network: a plural, diverse and intergenerational network of women leaders from governments, civil society, academia, and international organisations. This network is key to incorporating women into the centre of decision-making as protagonists of economic reactivation and economic and social protection policies.

Ultimately, recovery agendas have the opportunity to channel their investment into sectors that promote sustainable development by boosting competitiveness through green jobs and sustainable mobility policies in cities; health manufacturing; the bioeconomy and ecosystem services; the circular economy and sustainable tourism; the digital revolution, and the care economy. These are global challenges that imply multilateral agreements to facilitate debt relief and restructuring schemes and fairer taxation.

From the side of the EU-LAC Foundation, we will continue our efforts to dive into these common challenges, as a channel for plural, diverse, open, and permanent political and social dialogue between our regions. We will continue to foster the connection with civil society and citizens, through the visibility of a useful bi-regional agenda that favours the promotion of policies with a direct positive impact on the new course of recovery. We aspire to contribute to the journey together in order to find clear horizons and clear skies.



### ON THE 10TH ANNIVERSARY OF THE EU-LAC INTERNATIONAL FOUNDATION

Near the end of my first term in office as President of the Dominican Republic (1996-2000), I had the opportunity to participate in the first summit of Heads of State and Government of the European Union - Latin America and the Caribbean, held in 1999 in Rio de Janeiro, Brazil.

When I returned to lead the destiny of my country in 2006, I had the great opportunity to participate in other summits, which were memorable, both for the quality of the interventions and for the commitments made.

Due to the importance of the issues addressed and the mutual interest of the participants, a bi-regional relationship was forged and consolidated every two years with the holding of new meetings at the highest political level to address global issues, as well as those of a regional nature on both sides of the Atlantic.

This resulted in several strategic agreements and action programmes that allowed progress to be made in the implementation of political projects aimed at consolidating democracy, as well as economic and social initiatives for sustainable development, social equity, and cooperation to the benefit of the countries of both regions.

All this was taking place against the backdrop of a new stage in the reconfiguration of the international order. These were the first years of the emergence of another wave of globalisation, which strengthened a relationship of interdependence and interconnection between the different nations of the world. This scenario gave impetus to the establishment of regional and sub-regional blocs, which, because of their structuring, gave rise to renewed integration processes in Latin America and the institutionalisation of the European Union as a regional body.

Due to the various initiatives that emerged from the summits between the European Union and the Latin American region, with the aim of incorporating the different economic and social sectors of the member countries in the implementation of these initiatives, the creation of the European Union - Latin America and the Caribbean Foundation (EU-LAC) was approved in 2010, within the framework of the VI EU-LAC Summit, held in Madrid, Spain.

The following year, in November 2011, the EU-LAC Foundation was established in Hamburg, Germany, as a non-governmental, non-profit organisation dedicated to strengthening the biregional partnership between Europe and Latin America and the Caribbean.

Since its creation, the Foundation has been very successful in promoting mutual understanding between the two regions, as well as strengthening academic, scientific, social, cultural, technological, and environmental ties, thus achieving a higher level of integration between the two sides.

Now, in 2021, a decade after its creation, we note that the EU-LAC Foundation, through its various programmes, has played a relevant role in benefiting one of the most representative and significant bi-regional relations worldwide.

Particularly, I feel great joy to recall fond memories and experiences during our time as Presidency of the Foundation (2016-2020) when we were able to share working agendas with university rectors, academics, entrepreneurs, government officials, young leaders, and prestigious international institutions.

Since the beginning of our management of this important organisation, we have focused on working to strengthen,



promote, and consolidate the bi-regional agenda based on the close historical and cultural ties, as well as on the pillars, principles, and values shared between Europe and Latin America and the Caribbean.

In this four-year journey, I had the honour and privilege of sharing my duties with an exceptional person: Dr Paola Amadei, Executive Director of the Foundation, who, with her talent and sensitivity, contributed to the planning, coordination, and execution of a series of initiatives, activities, and spaces for reflection, focused on the promotion of culture, higher education, scientific cooperation, and the fight against climate change.

An important achievement during our term was the transformation of the foundation from a German civil society institution into an international organisation with legal personality and capacity to fulfil its objectives and purposes, thus marking an important milestone in the consolidation of the bi-regional partnership.

Of course, this important milestone is the product of the praiseworthy work and constant effort of a whole team that, over the years, and since its inception, has been building the foundations that support the bi-regional partnership between the Member States of the European Union and the Latin American and Caribbean States.

As a result of all these efforts, our communities now have an effective and representative instrument, intergovernmental in nature and subject to international law, with greater global scope and presence.

We cannot hide, however, that the current reality in both regions has changed dramatically. The global health crisis triggered by the COVID-19 pandemic has impacted internally in each of the countries of both regions, as have the dynamics of their relations.

In this sense, taking as a reference the fact that we are going through times of great change and uncertainty at the global level, the Foundation now has an even greater responsibility to work on the reactivation of bi-regional relations within the framework of summit diplomacy to continue working for the progress and prosperity of our people.

The Foundation, in line with its mandate to promote debate on common issues and actions to strengthen the bi-regional partnership, should contribute to stimulating in both regions the resumption of political dialogue, consensus building, and the creation of a public opinion oriented towards the consolidation of a stronger, more sustainable bi-regional partnership anchored in cooperation and solidarity.

As the EU-LAC Foundation celebrates its tenth anniversary, we can affirm with certainty that, in general terms, it has fulfilled the objectives that gave rise to its creation; and in these times of crisis and uncertainty the world is going through, it highlights its relevance and pertinence to continue promoting and advancing towards the consolidation of an authentic Euro-Latin American association.



The present document summarises the dialogue held during the Workshop "Exchange on progress made and opportunities for bi-regional cooperation in research and innovation one year after the agreement on the JIRI EU-CELAC 2021-2023 Strategic Roadmap", hosted by the EU-LAC Foundation on 19 October 2021 in close collaboration with Mexico, in its capacity as Pro-Tempore Presidency of CELAC (PPT CELAC), the European Commission's Directorate-General for Research and Innovation, and the LAC National Contact Points Coordinator.

The meeting was moderated by Dr Adrian Bonilla, Executive Director, EU-LAC Foundation, and Dr Anna Barrera, Senior Programme Coordinator, EU-LAC Foundation.

The objectives of this meeting were:

- To report on the process of the elaboration and approval of the Strategic Roadmap 2021-2023 of the EU-CELAC Joint Initiative on Research and Innovation (JIRI);
- To visualize the initiatives, programmes and instruments of the EU and LAC that have been adopted and that will be opened soon to strengthen the CELAC-EU Common Research Area, including funding sources, modalities, procedures and criteria for participation;
- Share information on the progress of the work in each of the JIRI pillars from November 2020 to October 2021;
- Generate an exchange of ideas and proposals on how to dynamise and concretise the initiatives in each of the pillars and achieve a greater impact.

## Opportunities for the bi-regional strategic partnership in shaping a greener recovery

The EU-LAC Foundation is pleased to present the publication "Opportunities for the bi-regional strategic partnership in shaping a greener recovery" that gathers the three winning essays of the II EU-LAC Essay Contest on the Bi-regional Partnership.

BELLA Impact: Latin America can tackle climate emergencies with high-speed and reliable access to vital Copernicus Earth Observation data

29 October 2021



Scientists, citizens and organisations want to help fight climate change for a brighter future, researching, developing and implementing innovative solutions that also create employment and drive economic growth.

Policymakers and public authorities around the world need to set legislation, make well informed choices, and often take critical decisions in the event of an emergency, such as a natural disaster or humanitarian crisis.

Without high-speed and reliable access to Earth Observation (EO) data this can be a real challenge and becomes absolutely critical in times of emergencies.

For example, an emergency worker in Latin America mapping a region of 500km2 would need at least an hour to download EO data over a standard commercial internet service.

In an emergency, saving time almost certainly means saving lives.

In the <u>EU-LAC Foundation's publication, coordinated by Andrés Serbin and Andrei Serbin Pont (CRIES) (2018)</u>, we pointed out the economic and financial importance of the European Union (EU) in Latin America and the Caribbean (LAC). This importance and relevance were embodied in direct investments and trade, involving value chains and technology transfer, as conditions for sustainable development. This relatively optimistic perspective was not the result of chance, but of the EU's persistence in establishing a bi-regional relationship based on trade treaties and political consultation and cooperation agreements with different countries, as well as a forum for political dialogue with the region, which finally culminated in the EU-CELAC Summits.
