EU-LAC RELATIONS: AN ENGINE FOR SUSTAINED AND SUSTAINABLE GROWTH

The LAC region is a "strategic partner" of the EU with which we want to "join forces for a common future", as outlined in the Joint Communication on EU-LAC relations (2019). Trade is a key component of the EU political agenda, and an important vector for the EU to promote its democratic values, rules and high standards. Since the early 2000s, the EU has concluded 11 bilateral and regional trade agreements with LAC countries (all countries except Mercosur, Bolivia and Venezuela). Just over the last decade, bilateral trade in goods with the region has increased by over 25%.

The EU is today a balance and counterbalance for US and Chinat"s influence in the LAC region, where it has considerable economic interests. An important feature of EU policy towards Latin America is its continuous support for regional integration and democratization, for which the EU offers a useful model, and it has done so also through trade agreements. EU-LAC trade agreements are market-opening tools but also tools for "good governance". They help secure third-country markets for EU goods and services and level the playing field so that we can compete on a fair basis, including by solving trade frictions. Moreover, these agreements provide legal certainty and security for businesses and investors, promote sustainability standards and constitute useful platforms for engagement and coordination in areas of joint interest. Trade remains a key driver for growth, innovation and competitiveness in both regions, and for our diversification strategy post-Covid. Latin America has played a role as a supplier of critical goods to the EU during the Covid-19 pandemic. This is especially true for pharmaceutical products, where EU imports from Mexico grew by ϵ 513 million in the first four months of 2020 – an equivalent of a 360% increase from 2019. Unfortunately, the Covid-19 crisis has hit Latin America harder than any other region of the world and the recovery remains fragile. Cooperation to address these challenges as well as the need to drive green, digital and inclusive recovery remain top of the EU agenda, and are the main themes of the recent EU-LAC Leader's Summit 2021².

In our pursuit for "open strategic autonomy"³, the EU needs to consolidate this strategic partnership by creating the necessary conditions for the ratification of the EU-Mercosur agreement and by concluding the modernized agreement with Mexico and Chile. This is a test for EU global ambitions. Bilateral trade with Mercosur represents 40% of EU trade with the region. China has already overtaken the EU to become Mercosur's main trading partner. Clearly, the fires in the Amazon will not be extinguished by pulling out from this agreement. Concerns over deforestation are best addressed via engagement and cooperation, and this agreement

provides a useful platform for that while contributing to the objectives of the Green Deal⁴.

Finally, the EU is stepping up its global connectivity efforts, also seeking to offer viable alternatives to China's 'Belt and Road Initiative' in regions such as Latin America through the Global Gateway initiative. This initiative can contribute to closing the infrastructure gap that is holding back competitiveness in the region by bolstering investment in digital, climate, energy and transport infrastructure⁵, and pave the way for greater regional integration to boost economic growth.

New challenges for the European Union's Multiparty Trade Agreement with Peru, Colombia and Ecuador


This document analyses the trade and cooperation relations between the European Union and the Andean countries with which the Multiparty Trade Agreement was signed (Peru, Ecuador and Colombia). It also examines the progress and challenges in terms of the sustainable development agenda, political dialogue and cooperation within the framework of the agreement. From there, it explores the different technical difficulties that have arisen in the implementation of the agreement and the role of the monitoring bodies. The aim is to study the strategic importance of the agreement in relations between the European Union and Peru, Ecuador and Colombia, and its contribution to the post-pandemic economic recovery and the promotion of new development models.

The Covid-19 Crisis and Pathways to Sustainable Recovery in the European Union, Latin America, and the Caribbean

The EU-LAC Foundation is pleased to present the publication "The Covid-19 Crisis and Pathways to Sustainable Recovery in the European Union, Latin America and the Caribbean" which compiles the interventions presented during a Keynote Lecture Series 2021 held virtually from July to September 2021 in collaboration with the Latin American Studies Programme of the University of Hamburg.

These conferences were implemented with the objective of contributing to the generation of knowledge and the exchange between scientists, civil society actors, public officials and decision-makers on the impacts caused by the COVID-19 pandemic in different political, economic and social sectors particularly affected by the pandemic, as well as on concepts, good practices and public policies that have been developed in Latin American, Caribbean and European countries to lead to a better and sustainable recovery of these sectors.

In doing so, the 2021 Keynote Lecture Series responded to some of the common priorities identified by the high authorities of both regions. In December 2020, at the EU27-LAC Informal Ministerial Meeting, the Ministers of Foreign Affairs of the European Union, Latin America and the Caribbean countries expressed their deep concern about the devastating impact of the coronavirus and "reaffirmed their determination to step up joint efforts to overcome the multidimensional challenges brought on by the Covid-19 pandemic, which risks exacerbating existing structural gaps, inequalities, social, economic and financial exclusion".

The Political Dialogue and Cooperation Agreement and relations between the European Union and Cuba

This document makes an assessment of the Political Dialogue and Cooperation Agreement (PDCA) between Cuba and the European Union (EU) in its four years of validity, and of the evolution of political and economic relations between both parties. The analysis is structured in five headings that address the background, determinants and significance of the PDCA between Cuba and the EU; the main elements discussed in the political dialogue —and in thematic dialogue— between the two parties since 2018, and the central aspects of trade, investment and cooperation relations between Cuba and the EU.

The report concludes that, unlike the United States, the EU is able to support the complex process of economic and institutional transformations underway in Cuba, in four fundamental areas: i) technical assistance and advice for the design and implementation of public policies, macroeconomic management, decentralisation and local development; ii) cooperation to fight climate change and transform Cuba's productive and technological structure; iii) the promotion and encouragement of foreign investment flows from Europe, targeting key productive sectors; and iv) the exploration of financial opportunities for Cuba through the European Investment Bank (EIB) under the current PDCA.

Circular Economy – Governance & Scale: Europe & Latin America and the Caribbean in conversation about circular transition

The webinar <u>"Circular Economy – Governance & Scale: Europe & Latin</u> America and the Caribbean in conversation about circular transition" took place on 22-23 November 2021 and was co-organised by the Ministry of Foreign Affairs of the Republic of Slovenia and the EU-LAC Foundation, in partnership with Exchange 4 Change Brazil (E4CB), Circular Change, and the Brazilian Centre for International Relations (CEBRI). It was held in the framework of the Slovenian Presidency of the Council of the European Union and was part of the celebration of the EU-LAC Foundation's 10th anniversary, in line with its area of work on Sustainable, Resilient and Inclusive Economy. The recordings (Part 1 and Part 2) are available on the <u>EU-LAC Foundation's You-Tube Channel.</u>

The event aimed at providing a platform for experts and business leaders from selected sectors to showcase their expertise and share best practices as well as to enable a high-level dialogue about opportunities for new partnerships to advance the circular transition. In this sense, the panels and keynotes allowed to shed light upon recent advancements in the field of circularity while contributing to raise awareness on the importance of overcoming the traditional notions of a linear and unsustainable economy. In particular, the potential of building on the post-COVID-19 recovery efforts of the European Union (EU) and Latin America and the Caribbean (LAC) to leverage the shift towards a circular economy on a global scale was emphasised.

The recovery as an opportunity for transformative social change: pathways towards an EU-LAC partnership for cohesive societies

The webinar "The recovery as an opportunity for transformative social change: pathways towards an EU-LAC partnership for cohesive societies" took place on 1 December 2021 and was co-organised by the 2021 Slovenian Presidency of the Council of the European Union, the European External Action Service (EEAS) and the Directorate-General for International Partnerships of the European Comission (DG INTPA) in partnership with the EU-LAC Foundation and the OECD Development Centre. The webinar was moderated by Mr. Tine Rus, diplomat at the Permanent Representation of Slovenia to the EU. The recording is available on the YouTube page of the EU-LAC Foundation.

The objective of the event was to highlight the challenge of strengthening social cohesion in the post-COVID19 recovery and discuss ways forward for the partnership between the EU and LAC region to address these challenges. The webinar was opened with a presentation of the main findings and recommendations of the 2021 Latin American Economic Outlook (OECD/ECLAC/EU/CAF), which feeding into the framework of Development in Transition, delves into options for rethinking the social contract and the role to be played by international cooperation.

The webinar brought together a wide range of leading experts from both the EU and LAC, to discuss the recovery as an opportunity for transformative social change, around three main angles:

- challenges to social protection with the focus on vulnerable groups and addressing informality;
- 2. the key role of fiscal policies;
- 3. options for transformative change in relation to more inclusive policy design and partnerships

Between 2010 and 2025, most Latin American countries celebrate the bicentenary of their independence from Spain and Portugal. At first sight, the Latin American independence appears to be a separation between Latin America and Europe. In 1825, the Spanish Empire in the Americas was reduced to Cuba and Puerto Rico, and there was nothing left of the Portuguese one. However, the independence at the beginning of the 19th century did not separate the Americas from Europe.
